

Migration processes have become one of the principal motors of the process of social, political and cultural transformation in our society. The transnational dimension forms part of the nature of migration movements, and it takes on special importance in the countries of the European Union. Dealing with the issue of immigration demands intense, urgent efforts in learning, designing conceptual frameworks and making policy and institutional innovations, which would permit facing the challenge posed with an integrative vision of the European dimension.

Through debate workshops and the annual Immigration and Europe Seminar, as well as different publications (such as the Migrations Documents, monographs, and the Interrogar la Actualidad collection - Immigration Series) and various activities, the Migrations Programme contributes to the development of debate and research on migration policies, with special emphasis on European immigration policy.

The Migrations Programme has established a collaboration agreement with the Diversity and Citizenship Policies Service of the Barcelona Provincial Council, and it participates in different initiatives at the European level.

## RESEARCH CARRIED OUT

- **IMMIGRATION, ADMITTANCE AND INTEGRATION POLICIES IN AUSTRALIA**

**Robyn Iredale**, Visiting Lecturer, Research School of Social Sciences, Australian National University.

This research project, framed within the area of research on the management of immigration and coexistence, analyses the process of change that Australia has been going through in the area of immigration and admittance over the past few decades. After a period in which migration flows were facilitated and an assimilationist model was promoted, the Australian government advocated for the multiculturalism that reigned until 1995. The new conservative Government made a change of direction in Australia's immigration, admittance and integration policies, which has marked an important point of inflection in this traditional country of immigration.

- **IMMIGRATION, ADMITTANCE AND INTEGRATION POLICIES IN CANADA**

**John Biles**, Director of the Partnerships and Knowledge Transfer Programme, Department of Citizenship and Immigration. Metropolis-Canada Project.

The objective of this research project is to provide an analytical description of the Canadian model of integration, based on concepts like multiculturalism and two-way integration and on specific policies and instruments. Within the framework of the area of research on the management of immigration and coexistence, this project aims to bring the concepts, instruments and debates used in Canada closer to the Catalan and Spanish realities in order to manage the coexistence of diversity.

- **IMMIGRATION, ADMITTANCE AND INTEGRATION POLICIES IN EUROPE**

**Ines Michalowski**, Researcher, Programme on Intercultural Conflict and Societal Integration, WZB - Social Science Research Centre, Berlin.

This research project aims to contextualise the classic models of integration that have been implemented in Europe over the past few decades, pointing out the difficulties that the models of multiculturalism, assimilationism and the guest worker have encountered in the countries in which they have been applied. This project, framed within the area of research on the management of immigration and coexistence, pays special attention to the immigration and integration policies applied in Germany, France and the Netherlands and contributes data on their evaluation and on their transformations in being adapted to new realities.

- **TWO CHALLENGES TO THE FRENCH REPUBLICAN MODEL: THE POLEMIC OVER VEILS AND THE REVOLTS IN THE BANLIEUES**

**Pol Morillas** and **Gemma Pinyol**, CIDOB Foundation.

Reluctance to remove one's veil in order to attend French public schools sparked an intense debate on the French secular model's capacity for adaptation. In addition, the revolts that took place in the peripheral neighbourhoods of many French cities toward the end of 2005 were a terrible blow to the image of France as an example of coexistence and social cohesion. The objective of this research is to reflect on the political response to these events and to consider whether or not these phenomena have signified a challenge for the French republican model.

- **BUILDING COEXISTENCE: IMMIGRATION AND INTEGRATION IN CATALONIA**

**Gemma Pinyol**, CIDOB Foundation.

Cultural, ethnic and linguistic diversity is one of the main characteristics of recent immigration to Catalonia. Attending to this diversity and adapting discourse to it have been the principal challenges of the institutions. This research aims to make a diachronic analysis of migration in Catalonia over the past few decades and to bring it closer to the political-institutional discourse that has been made on issues like immigration, coexistence and citizenship. For this reason, it takes into account the different immigration plans drawn up by the Generalitat of Catalonia, which allows one to become familiar with how the Catalan administration faces the challenge of managing the diversity and plurality in Catalonia today.

- **THE PRESS AND IMMIGRATION: ANALYSIS OF THE CONTENT OF LOCAL PRESS IN 2005**

The presence of immigration in the written press is an unquestionable constant, which has been taking on greater importance as the immigration phenomenon has. The objective of this research project is to examine a selection of news items related to immigration which appeared in the Spanish local and national press, in order to analyse which groups appear most repeatedly, which subjects are mainly highlighted and how these news items match the Style Book of the Official Association of Journalists of Catalonia in regard to the forming of archetypes, the use of generalisations, and negativity, among other elements.

- **SUB-SAHARAN EMIGRATION: MOROCCO AS AN AREA OF TRANSIT**

**Mohammad Khachani**, Lecturer in the Agdal College of Law, Rabat. President of the Moroccan Association for Studies and Research on Migrations.

Traditionally, Morocco has been a country of emigration, but currently it has become a country of transit for the migration flows heading to Europe from sub-Saharan Africa. This research project aims to analyse the transformation that Morocco has undergone, and at the same time, it seeks to reflect on the role that the European Union demands of transit countries in the struggle against clandestine immigration. The study aims to evaluate whether or not the policies on both sides of the Mediterranean must focus on security as the only instrument for fighting against irregular immigration or if policies must be adopted that act upon the ultimate causes of migration flows.

- **THE MIDDLE EAST IN MOVEMENT: REFUGEES, DISPLACED PERSONS AND ECONOMIC IMMIGRANTS**

**Gemma Pinyol**, CIDOB Foundation.

In talking about population movements, few regions of the world present a dynamism similar to the countries of the Middle East. This is the region with the greatest proportion of refugees in the world, with active migration flows that go from Asia to America, passing through Europe and sub-Saharan Africa. The objectives of this research project are to show, in a broad way, the principal groups of refugees that exist in the Middle East and to offer a cartography of the main origins and destinations of the economic migrations that take place in the region.

• **THE URBAN REVOLTS OF NOVEMBER 2005 IN FRANCE: FROM THE ACTS TO THEIR INTERPRETATION**

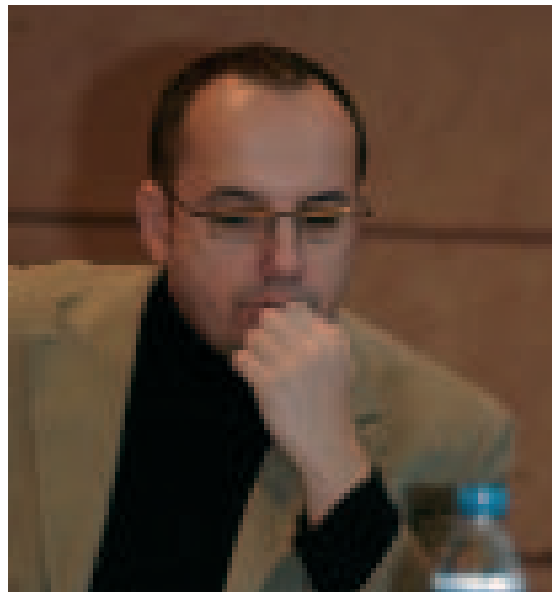

- **SUB-SAHARAN EMIGRATION: MOROCCO AS AN AREA OF TRANSIT**

During the session, analysis was made of the transformation of Morocco from a traditional country of emigration to one of transit which is supporting a strong migration pressure made up primarily of a sub-Saharan population. In the face of the limitations that the security approach has demonstrated in the area of immigration, Khachani underscored the idea that the migration policies of the two sides of the Mediterranean must demythify the security syndrome and break with the obsession of the migration risk, focusing their efforts on adopting a preventive, rational approach that would act upon the ultimate causes of migration flows.

- **ADMITTANCE POLICIES AND MODELS: THE CASE OF AUSTRALIA**

During the first session of the series, "Admittance Policies and Models", Professor Iredale highlighted the recent transformations in the Australia's integration and settlement policies, and she made a historical review of the main periods of immigration that the country has experienced since World War II. She indicated three different periods, the last of which began with the arrival of the conservatives into power in 1995, which have diluted the traditional policies of admittance aimed at the foreign population. She concluded that, in contrast to European countries, Australia has opted for a model that gives priority to a highly qualified immigration that needs few instruments of admittance and aid in order to be accommodated.

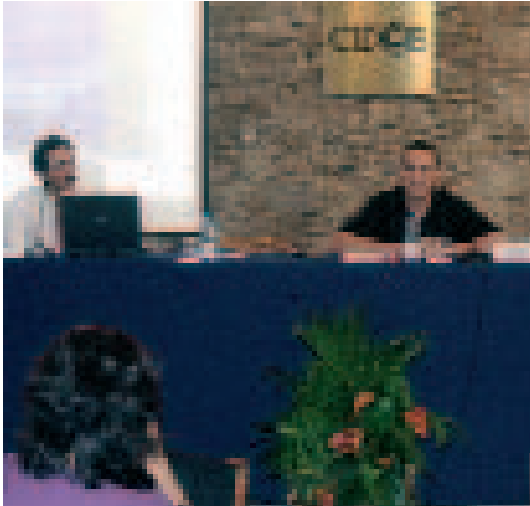
