



## Permanent International Seminar

This is a multidisciplinary platform that aims to foster the circulation of ideas among different societies through studies, seminars, conferences and publications.

Through the RICEI Network motor group, concrete topics with an intercultural dimension are proposed for a subsequent interdisciplinary debate (seminars and conferences), to which experts and professionals from different fields related to interculturality are invited.

These seminars are held in the CIDOB Foundation or in another collaborating centre. At the end of the encounters, the transversal lines of the debates are compiled and published together with the most important lectures, with the objective of promoting reflection and the study of intercultural dynamics.

## RICEI Network

RICEI proposes the organisation, at a national and international level, of meetings among researchers, conferences and seminars, with the aim of promoting research in the area of interculturality.

Generally speaking, its objective is to take up initiatives that can lead to the progress of knowledge in this specific area, disseminating the results of research projects and multiplying relations among the different disciplines comprising it.

With regard to the network of individual and group competencies, the RICEI can create permanent mediation for its members, facilitating the carrying out of projects, making consultations and receiving advice in the area of interculturality.

RICEI is made up of a co-ordination committee, a technical secretariat and occasional collaborators.

The Network holds an annual meeting in one of the centres proposed by its collaborators. During the annual meeting, the Network approves the admission of new members, draws up its programme of scientific activity and proposes research projects.

Currently its technical secretariat is located in the CIDOB Foundation.
